# Connecticut River Joint Commissions FY2015 Annual Report

July 1, 2014 to June 30, 2015

- In February of 2015 Commissioners engaged in a day-long retreat facilitated by Michele Tremblay of Naturesource Communications to update the Joint Commissions Strategic Plan. The Commissioners formed subcommittees on development, planning, and communications and will play active roles in steering the organization in the upcoming year.
- Glenn English of the Connecticut River Byways Council presented that organization's new tourism brochure and website at <a href="http://www.ctriverbyways.org">http://www.ctriverbyways.org</a>. The Byways Council and Joint Commissions explored opportunities for additional collaboration in the future.
- Ann Ingerson, Program Coordinator with Watersheds United Vermont (WUV) briefed Commissioners on the work of the WUV including water quality monitoring, river cleanup, and riparian buffer plantings in the watershed.

### **Public Outreach**

CRJC's website <a href="www.crjc.org">www.crjc.org</a> is simple to access and can be edited using a web-based interface. The new website makes CRJC publications and events easier to locate. It includes an events calendar for CRJC meetings/events as well as partner events and local river subcommittee meetings.

# **Local River Subcommittee Activities**

The local river subcommittees provide local input on projects proposed on the Connecticut River to NHDES, VANR and municipalities on matters pertaining to the river. Staff support is provided by North Country Council with funding from the states of New Hampshire and Vermont.

### **Headwaters**

Headwaters Subcommittee reviews and comments on proposed permits and plans; and periodically updates a corridor management plan. In 2015, activities included:

 Reviewed and commented on Northern Pass applications to NHDES and on Draft Environmental Impact Statement for US Department of Energy Presidential Permit.

- ♦ Hosted presentation on Vermont's new shoreland regulations.
- Reviewed and commented on several permit applications.
- ◆ Reviewed and commented on Conte Refuge Draft Comprehensive Conservation Plan.
- ◆ Participated in update of CRJC strategic plan on behalf of Headwaters communities.
- ◆ Reviewed public access maps and made recommendations to NH Public Access Advisory Board.

### Riverbend

The Riverbend Subcommittee meets quarterly.

In 2015, activities included:

- ◆ Participated in discussions about the relationship between Vermont's new shoreland regulations and the Connecticut River impoundments.
- Reviewed and commented on several permit applications.
- ◆ Reviewed and commented on Conte Refuge Draft Comprehensive Conservation Plan.
- ◆ Participated on NHDES workgroup to develop statespecific pipeline spill response plan rules.
- Hosted presentations on habitat identification and protection projects being conducted in local watersheds such as ACT's Clean Water Healthy Trout initiative and NH Fish & Game's participation in the Eastern Brook Trout Joint Venture.
- ◆ Reviewed and commented on the VANR Draft Basin Plan for the Stevens, Wells, and Waits Rivers.

### **Upper Valley**

The Upper Valley Subcommittee reviewed and commented on a wide range of regulatory applications, including river shoreline stabilization, wetlands activity, stormwater management, utility and solar projects, and private waterfront structures.

- The subcommittee also participated in the Wilder Dam federal re-licensing process.
- An update of the Connecticut River Recreation Management Plan for the Upper Valley Region was published to report on existing and future recreation opportunities in the valley.
- The subcommittee reviewed the proposed Conservation Management Plan for the Silvio O.
   Conte National Fish and Wildlife Refugee encompassing the entire Connecticut River Watershed.

- In the Upper Valley area, subcommittee commented to the U.S. Fish and Wildlife Service on proposed conservation areas in the Mascoma and Ompompanoosuc river watersheds.
- The Upper Valley Subcommittee held a joint meeting with the Mascoma River Local Advisory Committee to discuss issues of mutual concern, including the restoration of the eroding banks by the K-Mart Plaza in Lebanon.
- The current chair Jim Kennedy attended the CRJC Retreat in Wilder. Goals discussed were strong and active membership, implementation of the Connecticut River Management Plan, and community outreach and education.

### Mt. Ascutney

The Mt. Ascutney Subcommittee meets every two months to discuss and act on a variety of river-related issues.

In 2015, activities included:

- ◆ Participated in discussions about the relationship between Vermont's new shoreland regulations and the Connecticut River impoundments.
- Held septic system education workshop for homeowners.
- Participated in FERC process for relicensing Trans-Canada's hydropower facilities in Wilder and Bellows Falls.
- Reviewed and commented on several permit applications.
- ♦ Assisted local community with plans for emergency access to the river.
- ◆ Reviewed and commented on Conte Refuge Draft Comprehensive Conservation Plan.

◆ Began work on update to the corridor management plan.

# Wantastiquet

Wantastiquet Subcommittee meets bi-monthly to discuss and act on a variety of river-related issues. Specific responsibilities include providing advice to NHDES, VANR and municipalities on matters pertaining to the river; reviewing and commenting on proposed permits and plans; and developing and periodically updating a corridor management plan.

In 2015, activities included:

- Participated in discussions about the relationship between Vermont's new shoreland regulations and the Connecticut River impoundments.
- Reviewed and commented on several permit applications.
- Hosted presentations on CRWC Source to Sea Clean-up, US Fish & Wildlife Draft Plan for the Conte Wildlife Refuge, and NH Rivers Council River Runners training on identifying invasive aquatic plant species.




