Minutes (No Quorum)

1. Review of Conference Call Tools and Public Meeting Guidelines

Chair Walling began the meeting without a quorum, conducted via conference call, at 7:15 PM.

2. Welcome and Introductions

Chair Walling welcomed all and invited LAC members and any guests to introduce themselves.

3. Meeting Minutes

Postponed to next meeting.

4. Permit Reviews

a. Wetlands permit for driveway, Lunenburg, VT

Uyizeye gives a brief overview of the permit for a 15 ft wide driveway on an old farm/wood rd through wetland. Two main crossings are identified where culverts will be replaced with 15" structures. No tree removal is required.

Labun and Piper reviewed the permit and agree that it is an improvement and the modifications appear harmless. Walling indicates that an unofficial comment letter from members present might highlight best management practices that minimize wetlands impacts.

Graves appreciated the bringing of this permit to the LRS and encourages this to continue. Graves notes it was done but had not seen one for a couple of years. Consensus among attending members to share an unofficial comment in regards to the application.

5. Other Business

a. Water quality testing sites

Uyizeye shares the list of potential testing sites, with 8 highlights. Piper and Labun both indicate a site near their home they would be willing to do testing on. The question arises whether all sites have to be performed on the same day or if equipment can be passed between members and testing done on different days on each month. WaGoodlling will follow up with NHDES and pass information back to members.

Walling asks members to email Olivia with any additional sites they would be willing to take on. Even if only a couple of sites are able to be done, this is beneficial with the possibility to enlist a youth group to help maintain the effort. The idea of these sites is to identify pollution that might occur upstream of the testing site.

b. Community Article

Uyizeye is writing and article for each LRS to be shared broadly among all communities to improve public awareness. Walling suggests using information from the management plan and to have members review a draft with additional comment. Labun also notes the increased camping as part of the Connecticut River Trails. Walling with confirm the name of the local contact for the organization. Uyizeye will share a draft when ready.

6. Adjourn

The meeting is closed and members are thanked for their attendance.
