Meeting Notes

1. Welcome & Introductions

Chair David Taylor calls the meeting to order at 7PM. Taylor welcomes all present. Attendees and visitors introduce themselves, providing local updates.

- Manner. Big rainstorm coming down in Springfield. Connecticut River flowing near top of the bank.
- Beach. Minor flooding. Couple farm fields under water, getting cattle out.
- Bennett. Ottauquechee tributary is roaring.
- Howland. Out of Town.
- Taylor. Rocks out in the River near Edgewater Farm. River up to the top near those indicating a big flow. Illinois, very high winds and sandstorm, right after farmers turned the soil.
- Oklahoma dust bowl is how the NRCS got started, flooding in VT.

Merritt and O'Neill resigned. Members appreciated their contributions and wished them well. Renovation project to make the Cornish general store into a library and community center.

3. Permit Review

a. Ashley Ferry Boat Landing, Claremont NH

Improvement and normal boat landing maintenance reviewed. No comments.

b. Pesticide Permit, St Gaudens, Cornish NH

4. Updates & Other Business

a. Town/Member Updates

Bennett. Possible stormwater violation below industrial park. Considered too small for any major concern from permitting agencies.

Taylor. Keeping an eye on the banks of the River and especially tracking the river road renovations in Plainfield. Three corners improvement in Hartland also being monitored.

Stettner. Stoughton Pond underwater from the recent rain. Doing a few coliform tests near a possibly concerning site.

Manner/Howland. Ottauquechee Natural Resources Conservation District has a new district manager. Replacing a few failing culverts. Two culverts started failing in 2011. Pretty expensive project. Multi-use trail, culvert to bridge. Concern for increasing storm events. Cadie Brook.

b. WQ Season

c. SW Program

Uyizeye shares a grant proposal to address stormwater impacts on Nitrogen loading to the Connecticut River. The program focuses on municipal stormwater systems and permitting procedures. Members express support for the program.

Uyizeye updates members on actions to be taken by Commissioners based on their feedback this Winter. This includes an effort to attend meetings, confirmation of two riverwide speaker events and 1 social for all Commissioners and LRS. Also, an effort to explore priority projects.
