- a. Bohi talked to the department of public works. This road was not part of Hartford's Combined Sewer Overflow (CSO) project. Bohi described how the water goes into a ravine from the parking lot into a swale and a pond and then into an unnamed stream. All businesses must treat on-site. DPW said if they have a permit, it's the highest level possible and they should only worry if they don't have a permit. DPW also said it's been years since any water went into the stream.
